

**LEGAL NOTICE**

**TO THE TAXPAYERS OF THE DAVIS PARK FIRE DISTRICT:**

**NOTICE IS HEREBY GIVEN**, that a resolution was duly adopted by the Board of Fire Commissioners of the DAVIS PARK FIRE DISTRICT, Town of Brookhaven, County of Suffolk, State of New York, on the 11th day of May, 2019, subject to a mandatory referendum as provided for by Section 6(g) of the General Municipal Law.

An extract of the resolution is as follows:

The DAVIS PARK FIRE DISTRICT maintains a Reserve Fund designated as the Reserve Fund under Section 6(g) of the General Municipal Law in which account there is sufficient funds to accomplish the purpose hereinafter set forth; namely, purchase a class A pumper and required equipment, the cost of the vehicle will be reimbursed through a New York State Matching Grant. Purchasing the vehicle and equipment is necessary in order to maintain the high standards of performance of the DAVIS PARK FIRE DEPARTMENT in the discharge of its duties in preserving the lives and property of the residents of the community, and said class A pumper and equipment is deemed in the best interests of the residents of the DAVIS PARK FIRE DISTRICT. The resolution further provides that there be transferred from the present Section 6(g) Reserve Fund of the DAVIS PARK FIRE DISTRICT a sum not to exceed Three Hundred thousand (\$300,000.00) Dollars for the purchase, and the District Treasurer is authorized to effect such transfer from time to time to effect such purchase.

This resolution shall not take effect until a mandatory referendum is approved by the residents of Davis Park Fire District at the annual election to be held on July 9, 2019.

An extract of the resolution is as follows:

The DAVIS PARK FIRE DISTRICT maintains a Reserve Fund designated as the Reserve Fund under Section 6(g) of the General Municipal Law in which account there is sufficient funds to accomplish the purpose hereinafter set forth; namely , perform various building repairs to the electrical, structural and plumbing systems and equipment for firefighting operations. Making the building repairs and purchasing equipment is necessary in order to maintain the high standards of performance of the DAVIS PARK FIRE DEPARTMENT in the discharge of its duties in preserving the lives and property of the residents of the community, and said building repairs and equipment is deemed in the best interests of the residents of the DAVIS PARK FIRE DISTRICT. The resolution further provides that there be transferred from the present Section 6(g) Reserve Fund of the DAVIS PARK FIRE DISTRICT a sum not to exceed Fifty thousand (\$50,000.00) Dollars for the building repairs, and the District Treasurer is authorized to effect such transfer from time to time to effect such building repairs equipment purchases.

This resolution shall not take effect until a mandatory referendum is approved by the residents of Davis Park Fire District at the annual election to be held on July 9, 2019.
